Re: Interdistrict Cooperative Agreement

Attached for your approval is a copy of the Interdistrict Cooperative Agreement between Northwest Career & Technical Academy and the Stanwood-Camano School District. This is an ongoing agreement that is renewed annually and greatly benefits the students in our district.

This agreement will be utilized in the case where it serves a student in their best interest to attend the skills center at Northwest Career & Technical Academy. Prior to a student enrolling at the skills center, it will be determined that the placement is in the best interest of the student without fiscally impacting the Stanwood-Camano School District. I have been assured that whether or not any student attends the skills center, there will be neither a participation fee nor other fees assessed to our school district.

Recommendation: That the Board approves the 2020-21 Northwest Career & Technical Academy Interdistrict Cooperative Educational Services Agreement.



AGREEMENT FOR INTERDISTRICT COOPERATIVE EDUCATIONAL SERVICES 2020-2021 SCHOOL YEAR

The Agreement is hereby entered into by and between the Northwest Career & Technical Academy, Mount Vernon School District No. 320, Skagit County, Washington, which is hereafter referred to as the "Serving District" and

Stanwood-Camano School District, Snohomish County, Washington, hereinafter referred to as the **Participating District."**

The purpose of this Agreement is to utilize interdistrict cooperation, authorized by RCW 28A.355.160, RCW 28 28A.255.250, and Chapter 392-135 WAC, to provide educational programs not otherwise available and to avoid duplication of specialized programs and facilities. These objectives will be achieved by attendance at the Northwest Career & Technical Academy programs including the following:

Aerospace Manufacturing
Applied Medical Science (Nursing Assistant)
Aviation Technology
Automotive Services
Construction Skilled Trades
Criminal Justice & Public Safety
Culinary Arts
Dental Assisting

Drone and ROV Automation Fire Science & EMS Marine Services Money & Business Veterinary Assisting Video Game Development Welding Academy

This agreement gives the Northwest Career & Technical Academy permission to access student records data including address information from the data resource management center of the Participating District, to be used for all necessary Northwest Career & Technical Academy operations.

The Cooperative anticipates implementing all or a portion of this agreement during the **2020-2021** school year. It is understood that students who attend the Participating District and the Serving District shall be funded for all classes up to 1.6 fulltime equivalents as determined by the Office of the Superintendent of Public Instruction per SB5790. This agreement is for the 2020-2021 school year, beginning on August 30, 2020 through August 31, 2021, and was approved by each respective Board of Directors.
